Overview of Test Report Document:

- The test report contains two core sections. The first section is the test result details. This identifies the product under test, the badges and chevrons successfully tested along with other test event details and the approved Test Lab signatory signature. The “Certification Status” section of that page is a non-normative section of the test report to provide some background on the badges and chevrons reported by the participating organization to inherit certification pending approval from the Certification Body. This section does not imply certification, but it is a reference to note certified badges and chevrons explicitly not tested.
- The second section is a reference to the Drummond Test Lab, a Drummond disclaimer of testing services and a reference to the testing process described in the Drummond Group Testing Guide for the Payer and Patient Access FHIR® Certification Program on the Drummond website
